THE FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION APPROVED THE IMPERILED SPECIES MANAGEMENT PLAN, THE RESULT OF A TEN YEAR EFFORT, WHICH CORRECTED THE STATUS OF STATE-LISTED SPECIES AND PROVIDING THE FRAMEWORK FOR GREATER PROTECTIONS. AT LEAST TEN SOUTHWEST FLORIDA SPECIES ARE NOW UPGRADED TO "THREATENED" CLASSIFICATION AND WILL NOW RECEIVE MORE PROTECTION FROM HARM AND HARASSMENT UNDER STATE LAW. THE CONSERVANCY PROVIDED DETAILED TECHNICAL INPUT INTO THIS PLANNING PROCESS, AND MANY OF OUR RECOMMENDATIONS WERE INCORPORATED INTO THE FINAL DOCUMENT.

THROUGH THE CONSERVANCY'S SUPPORT, ENTITIES IN COLLIER COUNTY WERE ABLE TO SECURE \$17,500 FROM A FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION GRANT TO MANAGE BEAR ATTRACTANTS. WHEN TRASH, PET FOOD, AND DUMPSTERS ARE UNSECURED, BEARS MAY GET ACCUSTOMED TO HUMAN SOURCES OF FOOD AND MAY NEED TO BE REMOVED FROM THE WILD.

IN A COLLABORATIVE SCIENCE-POLICY DEPARTMENT EFFORT, THE CONSERVANCY INSTALLED FOUR RED-COCKADED WOODPECKER (RCW) NESTING BOXES IN SLASH PINE TREES WITHIN THE PRESERVE OF A LOCAL GOLF COURSE. THE PRESENCE OF THESE BOXES MAY HELP ATTRACT RCWS TO THIS PRESERVE, AS THEY WILL SERVE AS "STARTER HOMES" AS THE BIRDS EXCAVATE MORE PERMANENT NEST CAVITIES.

OIL AND GAS/NATURAL RESOURCE EXTRACTION

THE CONSERVANCY SUPPORTED A BIPARTISAN BILL TO BAN FRACKING AND OTHER UNCONVENTIONAL WELL STIMULATION TECHNIQUES AT THE STATE LEVEL. WHILE THE BILL WAS NOT APPROVED DURING THE 2017 LEGISLATIVE SESSION, IT HAD WIDESPREAD SUPPORT AND WAS SPONSORED BY 18 SENATORS (HALF OF THE SENATE!) AND 29 REPRESENTATIVES.

CONSERVANCY STAFF PROVIDED DETAILED COMMENTS REGARDING THE REQUEST BY HENDRY ENERGY SERVICES FOR A PERMIT TO REACTIVATE AN INACTIVE OIL WELL FOR NEW PRODUCTION. OUR COMMENTS, WHICH WERE BASED ON CONCERNS REGARDING ECOLOGICAL IMPACTS, HELPED CREATE THE BODY OF EVIDENCE LEADING TO PERMIT DENIAL.

LAND

THE CONSERVANCY WAS A FOUNDING MEMBER OF THE 2016 YES ON CONSERVATION 20/20 GRASSROOTS COALITION ADVOCATING FOR VOTER APPROVAL TO CONTINUE THE TREMENDOUSLY SUCCESSFUL LEE COUNTY CONSERVATION 20/20 LAND ACQUISITION PROGRAM. THE BALLOT INITIATIVE WAS PASSED BY AN IMPRESSIVE 83.68% OF VOTERS. THIS NON-BINDING REFERENDUM SENT A CLEAR MESSAGE TO THE LEE COUNTY COMMISSIONERS THAT THE PUBLIC WANTS THE COUNTY TO CONTINUE CONSERVATION ACQUISITION.

LEE COUNTY COMMISSIONERS VOTED UNANIMOUSLY TO PURCHASE ALL 6 SECTIONS OF EDISON FARMS FOR \$42.4 MILLION THROUGH LEE COUNTY'S CONSERVATION 20/20 LAND ACQUISITION PROGRAM. EDISON FARMS HAS LONG BEEN RECOGNIZED AS HAVING EXCEPTIONAL ECOLOGICAL VALUE. IT ENCOMPASSES ALMOST 4,000 ACRES OF VITAL WETLANDS AND PRIMARY PANTHER HABITAT.

THE CONSERVANCY PURCHASED FROM JOHN AND FOREST REYNOLDS A CONSERVATION EASEMENT ON 65 ACRES IN THE PEACE RIVER REFUGE FLORIDA FOREVER PROJECT. THE FUNDS FOR THE PURCHASE WERE MADE AVAILABLE THROUGH A SETTLEMENT AGREEMENT BETWEEN ENVIRONMENTAL GROUPS AND MOSAIC FERTILIZER, LLC. THE 65 ACRES OF ENVIRONMENTALLY SENSITIVE LANDS ARE THE FIRST TO BE PROTECTED WITHIN THE PEACE RIVER REFUGE FLORIDA FOREVER PROJECT, AND THE EASEMENT WILL BE HELD BY THE DIVISION OF STATE LANDS (DSL) THROUGH A MEMORANDUM OF AGREEMENT BETWEEN THE CONSERVANCY AND DSL.

THE CONSERVANCY DONATED TWO ECOLOGICALLY VALUABLE PARCELS OF LAND TO THE STATE FOR INCLUSION IN THE ROOKERY BAY NATIONAL ESTUARINE RESEARCH RESERVE. THE PARCELS ARE PRISTINE COASTAL HABITAT AND THEIR INCLUSION IN STATE LANDS WILL ASSIST IN LONG-TERM MANAGEMENT AND HABITAT PROTECTION.
